

# CLYNK 12 DAYS OF GIVING : 2020 OFFICIAL RULES

**Dates:** This promotion begins at 8:00:59 a.m. ("ET") on **12/24/2019**, and ends at 05:00:59 p.m. ET on **01/05/20** (the "Promotion Period"). Winners will be announced **12/25/2019** through **1/7/2020**.

**Eligibility:** Entrant (anyone who has an individual CLYNK account, excluding CLYNK to Give accounts) must have a bag processed on or between 12/23/2019 and 1/5/2020 in Maine or New York.

**Overview:** During the CLYNK 12 Days of Giving contest, for every bag processed in the contest period, customers will receive one (1) entry for that day's \$100 giveaway, plus be entered for an opportunity to win a \$1000 grand prize announced on January 7, 2020.

**To Enter:** CLYNK customers (excluding CLYNK to Give accounts) in either Maine or New York can enter. **Specifics:** 1) Entrant collects and CLYNKs redeemable containers. 2) Entrant drops bag of redeemable containers to be processed between **12/20/19 and 1/3/2020** to account for the two business-day processing window. Each bag processed between **12/24/2019 and 1/5/2020** is considered one (1) entry. The contest is only applicable to individual CLYNK accounts in Maine or New York. Entrants are solely responsible for transporting redeemable containers to an existing Hannaford Supermarket CLYNK drop location. CLYNK is not responsible for collecting entrant containers at individual homes or other facility. Entrant containers will only be counted if brought to a CLYNK drop location, bagged and tagged in accordance with CLYNK account holder standards.
